- 4** Make necessary repairs to the water damaged wall and ceiling in the following areas; gymnasium office, stairwell #3 and girls' restroom 2nd floor. (Sec. 9-1-303)
- 5** Scrape and paint the following areas; rooms 111, 115, 119, 201, 207, 209 and 116; restroom, entrance #1. (Sec. 9-1-304)
- 6** Make necessary repairs to the defective floor covering at the following location(s); stairwells 1 & 3; rooms 211 and 216; hallways 1st and 2nd floor; teacher's lounge. (Sec. 9-1-304)
- 7** Make necessary repairs to the missing ceiling tile at gymnasium. (Sec. 9-1-303)
- 8** Submit an approved report by a competent workman confirming the structural integrity of the masonry stack (18" in diameter and 25' or more in length). (Sec. 9-1-35)
- 9** Make necessary repairs to restore hot water to sink at classroom 108 restroom. (Sec. 9-1-441)
- 10** Make necessary repairs to entrance 1 stairs. (Sec. 9-1-103)
- 11** Make necessary repairs to urinals at second floor boys' restroom. (Sec. 9-1-441)
