- 5 Make necessary repairs to the defective floor covering at the following location; 204, 212, 307, Library 225, and Auditorium. (9-1-304)
- 6 Make necessary repairs to the leaking radiators in the following areas; throughout building. (9-1-463)
- 7 Make necessary repairs to pipe insulation in Gymnasium. (9-1-462)
- 8 Restore exit sign rear of Gymnasium. (9-1-10)
